

SurTec® 108

Recyclable Builder, Anticorrosive

Properties

- alkaline liquid
- free of silicates and surfactants
- recyclable in combination with SurTec 089 via membrane filtration, separator or gravitation oil separator
- suitable for spraying, flooding or continuous lines in combination with SurTec 085
- for spray application together with SurTec 084 or SurTec 086
- emulsifying in combination with SurTec 092 and SurTec 415
- suitable for iron, steel and magnesium
- temporary corrosion resistance on iron and steel

Application

In combination with surfactant boosters, SurTec 108 is suitable for soak-, ultrasonic- and spray processes. Oil, grease and pigments are removable without problems.

make-up values: 2 - 5 %vol SurTec 108
+ 0.1-1 %vol surfactant

temperature: 40-90°C

application time: 0.5-10 min

Maintenance and Analysis

Analyse and adjust the concentration of SurTec 108 regularly.

Sample Preparation

Take a sample at a homogeneously mixed position. Let it cool down to room temperature. If the sample is turbid, let the turbidity settle down and decant or filter the solution.

SurTec 108 – Analysis by Titration

reagents: 0.1 N hydrochloric or nitric acid
indicator: methyl orange solution (0.04 %)

procedure: 1. Pipette 10 ml bath sample into a 250 ml Erlenmeyer flask.
2. Dilute to approx. 100 ml with deionised water.
3. Add 3 drops of indicator.
4. Titrate with 0.1 N acid from yellow-orange to red.

calculation: consumption in ml · 0.28 = %vol SurTec 108
